

**INVITATION TO QUOTE CS 02-11**  
**NUKKO LAKE COMMUNITY HALL LANDING & RAMP ADDITION**

The Nukko Lake Recreation Commission, which operates the Nukko Lake Community Hall located at 23485 Chief Lake Road, Nukko Lake, B.C., twenty-three kilometers northwest of the City of Prince George, in cooperation with the Regional District of Fraser-Fort George invites written quotations from qualified contractors for the following:

1. The removal, disposal and cleanup of the existing north back landing, ramp and stairs at the Nukko Lake Community Hall.
2. The supply of materials and labour to construct and install a new back landing with access stairs and wheelchair accessible ramp in accordance to the attached drawings, to be completed by September 30, 2011.

**Additional Requirements:**

1. The Contractor shall obtain and pay for all licences, permits, approvals, and insurance required under the laws of the Province of British Columbia with regard to its own activity for this project.
2. The Contractor shall save harmless the Regional District from any liability and the Contractor shall have and maintain, for the duration of this project, commercial general liability insurance in the amount of two million dollars (\$2,000,000) per occurrence as a minimum and the Regional District shall be identified as an *additional insured* on the Contractor's insurance policy.
3. Prior to undertaking any of the work in this project, the Contractor will provide a clearance letter from WorkSafeBC showing their registration number and will keep current all assessments required to be paid in relation to the contract amount for the duration of this project.
4. A **signed**, completed copy of this invitation to quote, as well as signed copies of any applicable addendums, must be delivered or faxed to Ms. Meredith Burmaster, Community Services Leader by 2:00 p.m. local time, July 21, 2011. The respondent's **name, signature and address must be clearly filled in**. Quotations received after the stated closing date and time will not be considered by the Nukko Lake Recreation Commission. It is up to the respondent submitting the fax to verify that all pages were received intact and are legible by phoning the Regional District Service Centre at 250-960-4400.
