ADDENDUM No. 6

**Request for Prequalification CS-20-01
GENERAL CONTRACTOR PREQUALIFICATION
FOR PUBLIC SAFETY OPERATIONS BUILDING**

*The addendum is being issued prior to the closing of the request for prequalification (RFP) to provide further information, make changes to, or to clarify the RFP documents and is to be read, interpreted and coordinated with all other parts of the RFP documents. In the case of a conflict with the balance of the documents, this Addendum shall govern. **Proponents shall attach a signed copy of this addendum to their proposal submission, failure to do so may result in a non-compliant proposal.** This addendum shall form part of the Contract Documents.*

This addendum is an owner's issued addendum to provide clarification to RFP CS-20-01 released January 16, 2020.

CLARIFICATION 1: Delete Section 4.6 Similar Projects in its entirety, and substitute the following:

Proponents must provide a summary of at least four (4) "Similar Projects", with a construction value equal to or greater than \$1.5 million (\$1,500,000) dollars constructed within the past seven (7) years. Proponents are to complete the Similar Project Information Form provided in Appendix B.

Project experience – Provide a list of four (4) similar projects for each of the following:

- **key construction projects completed in the past seven (7) years;**
- **comparable construction projects completed;**
- **key construction projects underway.**

Proponents are required to describe each Similar Project in some detail (1 page per project maximum), including major sub-trades, schedule timelines and final construction cost.

CLARIFICATION 2: Delete Section 5.4 Experience with Similar Project in its entirety, and substitute the following:

Proponents must provide a summary of at least four (4) "Similar Projects", with a construction value equal to or greater than \$1.5 million (\$1,500,000) dollars constructed within the past seven (7) years.

Proponents are required to complete the Similar Projects Information Form provided in Appendix B for each Similar Project.

Project experience – Provide a list of four (4) similar projects for each of the following:

- **key construction projects completed in the past seven (7) years;**
- **comparable construction projects completed;**
- **key construction projects underway.**

Proponents are required to describe each Similar Project in some detail (1 page per project maximum), including major sub-trades, schedule timelines and final construction cost.

The information on Similar Projects will be evaluated based on complexity, size and comparison to the RDFFG Public Safety Operations Building Project.

CLARIFICATION 3: Due to the option for electronic submission of the proposal, it is acceptable for the original PDF of the CCDC-11 (unsealed) to be electronically inserted into the proposal.
