Members of the Miworth Community Association and Regional District staff will be making presentations.

BACKGROUND

The Miworth Community Association approached the Regional District in the 1980's to enter into agreements for use of the hall property and the skating rink property. These property use agreements have been in place since that time and give the responsibility of using, operating and managing the facilities to the Association. The Association pays for all of the costs of maintaining the properties and for the costs of programs and events it hosts.

In recent years, it has become challenging for the Association to engage volunteers, access grants and fundraise to pay for the expenses of keeping the two properties maintained. The Community Association has approached the Regional District to look into the feasibility of establishing a taxable service that would provide consistent funding for the operation of the hall and skating rink properties.

This proposal is now at the public consultation stage and the Regional District would like to provide information at this meeting on what a taxable service would entail and what the affect would be to property owners if it was established. You are being encouraged to attend this meeting to provide feedback about this proposal. If you cannot attend, please feel free to reach out to a Community Association members or Regional District staff for more information.

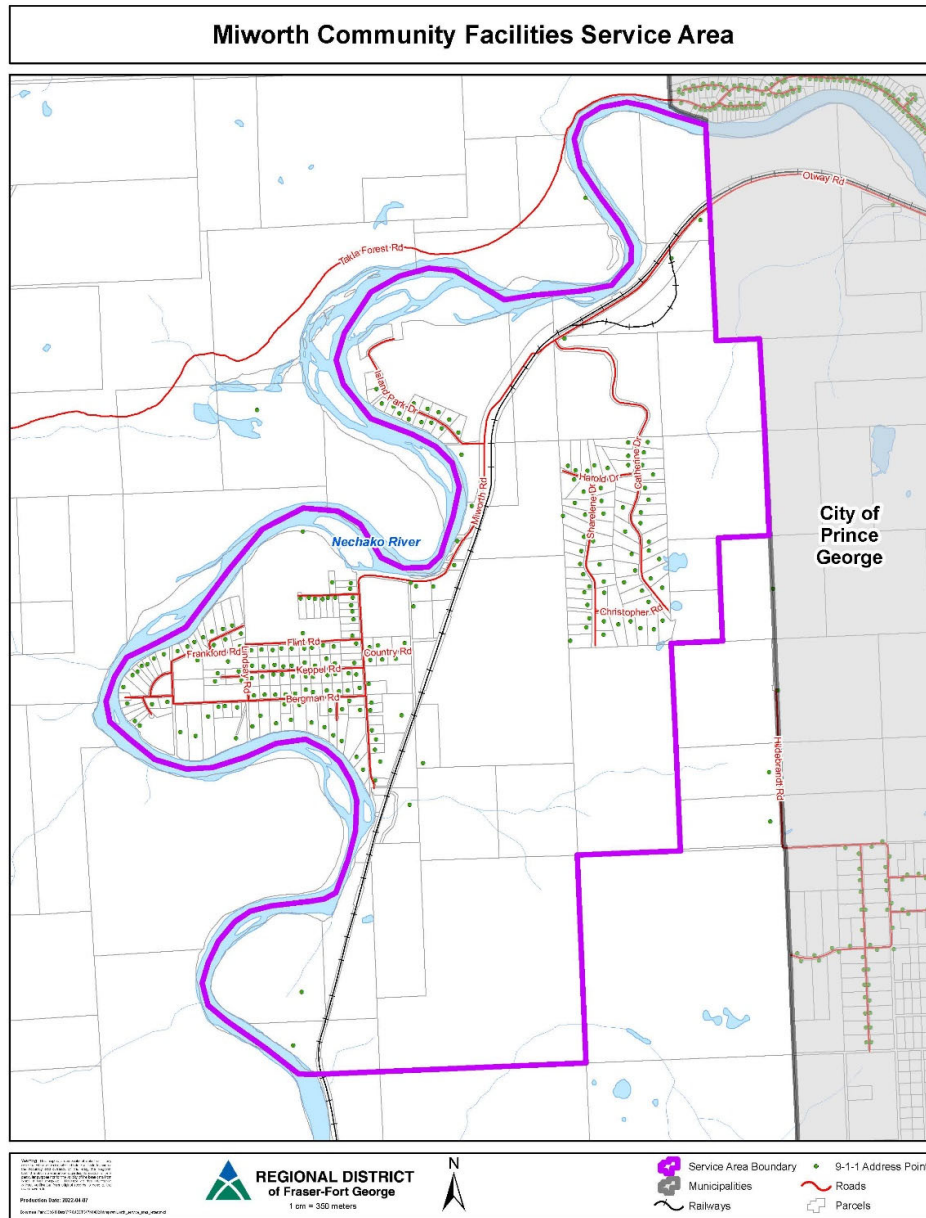
