ADDENDUM No. 1

**Invitation to Quote CS-21-10
SNOW CLEARING SERVICES – PUBLIC SAFETY OPERATIONS BUILDING (PSOB)**

*The addendum is being issued prior to the closing of the Invitation to Quote (ITQ) to provide further information, make changes to, or to clarify the ITQ Documents and is to be read, interpreted, and coordinated with all other parts of the ITQ Documents. In the case of a conflict with the balance of the documents, this Addendum shall govern. **Bidders shall attach a signed copy of this addendum to their bid submission, failure to do so may result in a non-compliant bid. This addendum shall form part of the Contract Documents.***

This addendum is being provided in clarification to ITQ CS-21-10 released October 22, 2021.

Change under 3.0 Scope of Work on page 4

Shall be changed to read: Contractor will provide and operate heavy equipment. The Contractor will also provide the personnel, supervision, and labour to complete the snow clearing services and any other general service as specified in the Scope of Work contained herein. The work includes removing snow from road surfaces and other identified areas and the piling of snow into designated snow storage areas.

Remove: At times, it may be necessary for removal of snow from the snow storage areas of the site. The Contractor may elect to use their own equipment or to sub-contract out this work. Bidder to specify the price of snow removal from the site under Price of Equipment per Hour on the schedule of Prices/Services, page 15.

Change under 3.3 Scope of Work on page 5

Shall be changed to read: The Contractor will commence snow clearing activities when the accumulation of snow is 10cm or more between 11:00 p.m. and 5:00 a.m. Snow clearing works should be completed during the hours of 9:00 p.m. and 6:00 a.m. if conditions allow.

Change under 5.2 Mandatory Site Meeting on page 6

Shall be changed to read: The meeting is scheduled to start at promptly **1:00 p.m. Thursday November 4th, 2021** at 2259 Quinn Street, Prince George BC. Submissions from bidders who did not attend the mandatory site meeting will not be considered.

Change to 5.3 Closing Date and Time on page 6

Shall be changed to read: Submissions to ITQ CS-21-10 will be received until 2:00 p.m. local time on Wednesday November 17th, 2021. Submissions received after the stated closing date and time will be disqualified and not considered by the Regional District.

Change to 5.6 Inquiries/Clarifications on page 7

Shall be changed to read: Any requests for explanations, interpretations, or clarifications made by bidders must be submitted in writing by email no later than 4:00 p.m. on Wednesday November 10, 2021, in order that addenda, if necessary, are available to all bidders in time to be considered for the preparation of their submissions.



Change to Schedule of Prices/Services on page 15

Remove: Snow removal from the assigned area to the Site on an as required basis when Project Manager or their designate requests the service. Price per 10 yd³ dump truck load or equivalent (GST not included).

Please use revised Schedule of Prices/Services sheet attached to this addendum when quoting a price.
